2020 Coronavirus (COVID 19) Response

The 2020 calendar year was unique due to the COVID 19 pandemic. The Lorain Municipal Court was directed by the guidelines developed by federal, state, county and local directives to modify the daily practices and procedures in order to protect and serve the public doing business with the court.

In the middle of March, 2020 the Lorain City Administration closed Lorain City Hall to the public and directed all departments to modify the working conditions for the employees. If possible, employees were directed to work remotely or maintain social distancing and wear face masks whenever they could not maintain social distancing. This created a unique work environment for the court. Judge Mihok, Judge Elwell and Clerk of Court Kalo developed procedures and practices designed to protect the employees and public from COVID 19.

Court hearings for traffic, misdemeanor criminal, civil and small claims were suspended from March, 2020 to April, 2020. Civil Evictions were accepted but not scheduled from March 26, 2020 through June 26, 2020 in compliance with a federal moratorium set forth in the CARES Act, March, 2020. The suspension/deferral of evictions cases was extended through March 31, 2021.

In March of 2020 traffic cases, other than OVI or Driving Under OVI Suspension, were allowed to be adjudicated through a waiver process either telephonically or through the Lorain Municipal Court payment portal. Cases for OVI, Driving Under OVI Suspension and criminal arraignments and hearings were scheduled to begin in June, 2020. Limited civil and small claims cases were also scheduled to begin in June, 2020.

Criminal Felony and Misdemeanor cases in which the defendant was in jail were heard through remote access from the jail to the courtroom. These cases were either bound over to the Grand Jury (Felonies) or scheduled for hearing/trial (Misdemeanor Criminal, OVI and Driving Under OVI Suspension) starting in June, 2020.

As the year progressed the court resumed limited operations following COVID 19 safety protocols. The second “wave” of infections prompted the court to once again limit exposure and curtail operation in October, 2020. Procedures and policies enacted in March, 2020 were resumed through the end of 2020 and into 2021.

The result of these COVID 19 policies diminished the court’s ability to schedule cases and collect revenue. The various law enforcement agencies were forced to decrease enforcement efforts for both the safety of law enforcement officers and the general public. The reduction of enforcement efforts continues into 2021 as the pandemic continues to devastate the State of Ohio.

Even though 2020 was a difficult year it did provide for the advancement in the use of technology to continue operations for the Lorain Municipal Court. The court installed a new case management system from the Pioneer Technology Group “Benchmark” activating the system on July 27, 2020. The conversion, for the most part, has progressed acceptably and should provide the security and stability the previous system lacked. The installation of the Benchmark court administration system should provide the capabilities necessary for tracking, payment collection and reporting needed for the court and its jurisdictional partners.

Recovery of 11/17/2014 Advance to the City of Lorain

On November 17, 2014 the Lorain Municipal Court advanced the City of Lorain Auditor the amount of \$300,000.00 to offset the delinquent disbursements from the Lorain Municipal Court account(s) caused by the data services computer malfunction occurring on May 19, 2014. The Lorain Municipal Court spent several months recovering the data lost and the financial disbursements were delayed.

Subsequently, the data was recovered and all disbursements were made in total without any reduction to recover the amount advanced to the City of Lorain. Each year the Lorain Municipal Court has a \$300,000.00 deficiency due to the advanced money.

On **September 25, 2019** a procedure was established to recover the amount advanced to the City of Lorain. It has been determined that the bond amounts ordered for forfeiture will be applied to the City of Lorain advance until the entire amount of the advance is reimbursed.

Since the City of Lorain Local Costs are disbursed first, the bond forfeiture amount will be applied to a new revenue code that will move the amount forfeited from HOLD to Deposit and disbursed to the Lorain Municipal Court Criminal Division bank account and retained there in order to recover the \$300,00.00 deficiency.


