Lorain Municipal Court

(Additional Correspondences, New Administrative Orders, etc.)

Lorain Municipal Court implemented practices and procedures that increased the efficiency and public interaction with the public the court serves.

In October, 2023 the E-Filing project was completed for civil cases. A number of test attorney practices were selected for the final testing of the process. The results have been acknowledged by the testing subjects for the ease of use and the time savings they achieved by being able to file cases online and not having to come to the Clerk of Courts office or mailing in the filings. They saved hours in personal appearance for filing and days for mail in filings.

Final implementation has been scheduled for the jail inmate interface between the county jail and Lorain Municipal. When finalized this process will insure a speedy arraignment of defendants housed in the Lorain County Jail.

The court has continued to upgrade and refine the communications to the public through the messaging system in the court administration system (Benchmark). The upgrades have contributed to the uptick in payments from defendants for fines and costs.

Overall, the court has enjoyed an overall increase in payments for fines and costs. Revenue received through the Lorain Municipal Court Clerk of Court Office has increased by 43% over 2022.
(Note: The increase from 2020, the Covid Year, is 82%.)


