2024 Lorain Municipal Court

Lorain Municipal Court implemented practices and procedures that increased the efficiency and public interaction with the public the court serves.

In December, 2024 the E-Filing project was completed for criminal/traffic cases. A number of test attorney practices were select for the final testing of the process. The results have been acknowledged by the testing subjects for the ease of use and the time savings they achieved by being able to file cases online and not having to come to the Clerk of Courts office or mailing in the filings. They saved hours in personal appearance for filing and days for mail in filings.

Final implementation has been scheduled for the jail inmate interface between the county jail and Lorain Municipal Court. When finalized this process will insure a speedy arraignment of defendants housed in the Lorain County Jail.

The court has continued to upgrade and refine the communications to the public through the messaging system in the court administration system (Benchmark). The upgrades have contributed to the uptick in payments from defendants for fines and costs.

The Court's Driver's License Renewal Program was able to restore driver's licenses to 117 people in 2024.

The Risk Assessment program made 1,307 assessments of persons arrested before their first appearance in court, to give the judge a better idea of their risk level. Only Lorain Municipal Court does this in Lorain County.

There were 85 referrals to Safe Harbor. Risk Assessor, Nathan Dohanos, chairs the Lorain County Human Trafficking Coalition.

Lorain Municipal Court and the City of Lorain Prosecutor's office charged 224 defendants for a total of 613 charges in Lorain Municipal Housing Court and collected a total of \$31,696 in fines and costs for all Housing Court cases.

Lorain Municipal Court and the City of Lorain Prosecutor's office filed 372 cases for a total of 1,038 charges in Lorain Municipal Tax Court and collected a total of \$39,531 in fines and costs for all Tax Court cases.

Overall, the court has enjoyed an overall increase in payments for fines and costs. Revenue received through the Lorain Municipal Court Clerk of Court Office has increased by 12.83% over 2023.

In order to enhance the payment of fines and costs the Lorain Municipal Clerk of Court office has contracted with three collections agencies over the years. The current collections agency being used is Schuerger Law Collections. Since 07/01/2019 the Clerk of Court office has submitted 21,379 cases to collections with a value of \$11,488,632.11. Additionally, we continue to collect revenue on cases submitted to other collections agencies.




