Lorain Municipal Court

Lorain Municipal Court implemented practices and procedures that increased efficiency and public interaction with the constituents the court serves.

I Ohio Senate Bill 94 took effect October 24, 2024, requiring municipal courts to accept pleadings and documents by electronic filing, commonly referred to as e-filing. The bill gave courts a deadline of July 21, 2025, to implement and start accepting e-filings.

The Lorain Municipal Court Clerk of Courts has been compliant with the new requirements since the end of 2023; nearly 600 days prior to the required date. In 2025 the Clerk of Courts accepted over 1,305 new e-filed cases, a 35% increase over 2024, and 1,349 e-filed documents to existing cases, a 72% increase over 2024.

The Clerk of Courts expects these numbers to increase as more attorneys become aware that e-filing is available.

Final implementation is continuing for the jail inmate interface between the county jail and Lorain Municipal Court. When finalized this process will ensure a speedy arraignment of defendants housed in the Lorain County Jail.

The court has continued to upgrade and refine the communications to the public through the messaging system in the court administration system (Benchmark). The upgrades have contributed to the uptick in the amounts of payments from defendants for fines and costs.

Driver's License Rehabilitation Program succeeded in getting 113 people a valid license while assisting many more with license issues. Pretrials Risk Assessment grant was renewed for 2 years. 1182 risk assessments were performed at the County Jail. Also, 69 persons suspected of being victims of human trafficking were referred to Safe Harbor.

Overall, the court has experienced a decrease in money collected for fines and costs. Revenue received through the Lorain Municipal Court Clerk of Court Office has decreased by 6.1% less than 2024.

In order to enhance the payment of fines and costs the Lorain Municipal Clerk of Courts office has contracted with three collections agencies over the years. The current collections agency being used is Schuerger Law Collections. Since 07/01/2019 the Clerk of Court office has submitted 23,554 cases to collections with a value of \$12,761,594.93. Additionally, we continue to collect revenue on cases submitted to other collections agencies.

The Lorain Municipal Clerk of Courts finally received reimbursement of over \$675,000.00 from Lorain County for overpayments from 2013-2018. This reimbursement was distributed to the proper agencies as determined by the Ohio Revised Code.

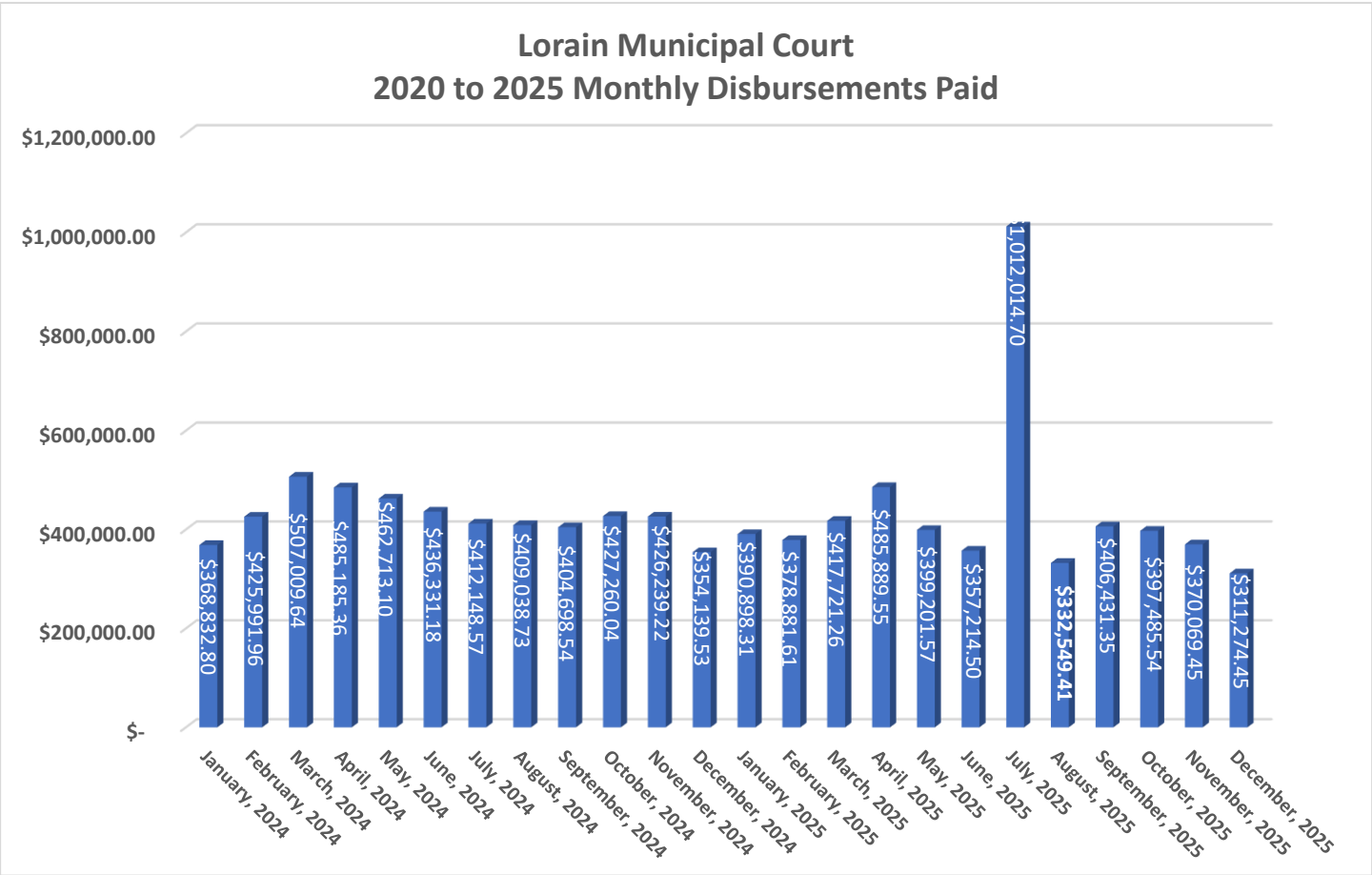
